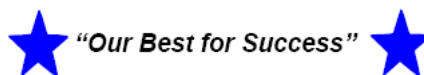

Dear Parent or Guardian,

I am writing to tell you about the Supplemental Educational Services (SES), or free tutoring, **for students who receive free or reduced-cost lunch.** SES will be offered outside the regular school day. The purpose of these services is to ensure that St. Stephens Elementary School students increase their academic achievement in reading and mathematics by getting extra help. If there is not enough funding for every **eligible** child requesting services, **students with the greatest academic need will receive first priority.**

A green information sheet is included with this letter to give you a description of each of the tutoring providers and their services. **St. Stephens Elementary will host a Provider Fair on Monday, September 19, 2011** at 5:00 p.m. This meeting will allow you, as the parent/guardian, an opportunity to meet prospective service providers and learn more about the services that each provider will offer. **I want to strongly encourage you to attend this Provider Fair.** As the parent/guardian, you will select which provider you want to provide the services for your child.

Also enclosed is a fact sheet with more information on the Supplemental Educational Services (SES). Please call me at **St. Stephens Elementary phone, 828-256-2570**, or the **Title I Director, Barbara Piekarski at Catawba County Schools Administrative Offices, 828-464-8333 ext. 180245**, if you have questions about tutoring services.

If you would like to request tutoring services, complete the **yellow registration form for each child and return the form to the school. The last day to register is September 23, 2011.** Attending the Provider Fair will give you more information to help you decide which provider best meets the needs of your child. After receiving your request for services, the district will assign a provider to your child and confirm your request by mail. Next, an agreement with the service provider, including specific achievement goals for your child, will be established and a start date will be set. SES services will begin the last week in October.

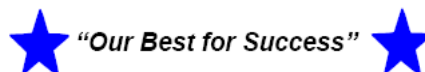
